FOREWORD

CLARKSON WAS FOUNDED in 1896 as a memorial to Thomas S. Clarkson by his three sisters, Elizabeth, Frederica and Lavinia. Thomas Clarkson believed that the most useful service a person could offer others was to help them to help themselves. His greatest dream was to establish an institution that would encourage youth to develop the best in themselves and, by practical application, give life and meaning to his philosophy. He was a devout man with a vision of education for all who sought it, and the Clarkson we know is a result of that vision.

The green and gold that are Clarkson's colors represent the colors of his favorite flower, the goldenrod. Clarkson's golden knight is outlined on the family coat of arms. Thomas Clarkson's convictions are expressed in a quotation from the Bible, "Study to show thyself approved unto God, a workman that needeth not to be ashamed."

In keeping with the precepts of Thomas Clarkson, many traditions have developed over the years. One of the most memorable of these was Moving-Up Day, which celebrated the symbolic end of the academic year when each class "moves up" to a higher academic level. A more recent designation for Moving-Up Day is the University Recognition Awards. At this time, superior scholastic and athletic attainment, public service and extracurricular activities are recognized by the presentation of awards and the honoring of campus leaders tapped for membership in Phalanx, Clarkson's highest honorary leadership society.

HISTORY

PRIOR TO 1929, students who participated actively in campus affairs and also attained high scholastic standing received no special recognition at Clarkson. That year, Phalanx was organized to honor such individuals. William M. Farrisee, then associate professor of civil engineering and later dean of students, assisted several members of the Class of 1929 in designating 12 charter members.

Now established as Clarkson's highest honorary society, Phalanx has stimulated campus activities and provided recognition of academic achievement, while promoting the qualities of leadership. Just as phalanx referred to the formation of ranks in ancient Greece, the society's constitution explains, "Phalanx means the formation of those who rank in the affairs of Clarkson."

The purpose of Phalanx has remained the same throughout its 92 years: to recognize the achievements and promote the interests of students in extracurricular activities, scholarship, service and athletics at Clarkson. Administrators, faculty and staff are now also recognized for leadership, service and teaching. Full consideration is given to a candidate's leadership qualities, including personality and the ability to lead and follow.

The University Recognition Awards is hosted by the Office of the President and Phalanx. This annual celebration recognizes members of the Clarkson University community who have demonstrated exceptional scholarship, leadership or service to the University.
